Group News. December

meeting. Once again we were very pleased to welcome Pat Savage the Glaucoma Nurse Practitioner from the Eye Clinic as our guest speaker, and to get an update on the work of

the Eye Clinic. e.g. we were reminded that Virtual Clinic appointments continue to take place on Mondays, Tuesdays and Wednesdays, and cover procedures such as pressures, fields, visual acuity and scans. Pat is there from 7.30am until 7pm, seeing patients and also checking on results from tests etc. with results determining as to whether the patient's condition is stable, or if a treatment change is necessary. Patients are called back for a mega clinic followup if any concerns are raised as a result of outcomes from the clinics. The Mega Clinics take place on Wednesdays and Thursday morning and Pat identified that although Mr Burnett doesn't have individual patient clinics at this time he is available to

advise, consult and examine patients who are sent/referred through to him based on results from the virtual clinics. Working alongide Pat and the doctors, there is also Emma –trainee glaucoma nurse practitioner, optometrist back up, and a retired GP who is there on Wednesdays and Fridays. Pat also as always addressed concerns raised by members and where appropriate, gave individual help, reassurance and advice, as well as general information. The main area of discussion this time round was eye drops - their availability, and also sensitivity to preservatives. Pat identified if this is a problem it should be mentioned in clinic so that a request can be made to the GP for a preservative free option to be prescribed., Members also commented on running out of drops before the next prescription is due. i.e. contents of bottle not lasting full month. Again Pat identified that this should be mentioned in clinic so that GPs can be made aware of the problem. Regarding dry eyes it was

emphasised that drops for this problem can be used as often as necessary during the day in order to alleviate the discomfort experienced. Other subjects raised concerned:communication difficulties - Pat reiterated her willingness to continue to have areas of concern passed on to her via her own personal mobile if necessary. I have her contact details in the event of any one needing advice, but she does however request that any phone calls are made within her working hours of Monday to Wednesday. It has always been very reassuring to know that phoning Pat's number would result in advice and an answer to a concern, and we were heartened to hear of this continuing arrangement. Questions were also asked about letters - Pat identified that virtual clinic appointments generate a patient letter; if seen by either herself or Mr Burnett a letter will be sent to your GP. Waiting times for acute angle closure glaucoma treatment were also discussed and identified. As with every

meeting Pat attends, her time was used in a very practical way, to help, advise and where possible solve individual problems of the group, both in general discussion, and individually after the meeting ended. Everybody found it very useful, and as always we have to thank her for the continuing support she gives the group, not just at the meetings but throughout the year as well. We were also very pleased indeed to hear that at the moment Pat has not included retirement in her plans for the coming year!
